

Pupil Premium Strategy Statement

Part A: Pupil premium strategy plan

Statement of intent

Main objectives:

- Closing the gap in attainment between our 'pupil premium' and 'non-pupil premium' pupils.
- Achieve national averages for attainment in all subjects.
- To maintain the positive progress 8 score for all pupils.
- To maintain high levels of attendance for all pupils.

How our strategy goes towards meeting these objectives? and, what are our key principles?

- Develop Teaching for Excellence through the use of Curriculum Planning sessions to facilitate teachers' exposition. Pupils will have engaging and purposeful lessons delivered by skilled professionals to ensure that they are equipped with the knowledge, skills and understanding to be successful.
- Develop the culture of independent learning for all pupils. Close the digital divide between 'pupil premium' and 'non-pupil premium' pupils by providing access to online platforms and by loaning devices to them on which they can complete online learning/homework. This enables all pupils to develop their independent learning skills and secure learning in their long-term memory.
- Targeted interventions within school that work with the National Tutoring programme (NTP) for KS4 Maths, English and Science.
- Attendance and behaviour support provided by AACs to ensure that behaviour is good all day, every day and that pupils are supported to develop the characteristics of our CARE brand and take responsibility for their own behaviour.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Improving Reading Ages across all year groups Diagnostic assessment and reading age tests indicate that a significant number of disadvantaged pupils have lower literacy skills Pupils need a reading age of 15.7 to pass exams at a 4+ parental engagement must be sustained to help reading to happen at home.
2	Identifying pupils who require SEMH support Pupils are not forthcoming at owning their emotions, pupils will give information in anonymous platforms but struggle elsewhere. Parental engagement must be sustained to help pupils feel open about emotions and mental health.
3	Maintaining attendance above National Averages Supporting pupils to display appropriate behaviours for learning and for interacting with others. Our attendance data indicates that attendance among disadvantaged pupils is lower than for non-disadvantaged pupils. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.
4	Develop teaching for excellence through the use of Curriculum Planning sessions to facilitate teachers to explain concepts clearly and that assessment is used effectively to identify underachievement and support pupils to close the gap in their knowledge, skills and understanding.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

	<p>94% of our targeted Y7 pupils improved their reading ages. 100% of our targeted Y8 pupils improved their reading ages. 78% of our targeted Y9 pupils improved their reading ages.</p> <p>All pupils who have decreased have been screened by the progression tools for SLCN and all pupils have completed a WRAT5. The screening tools will help identify areas of need.</p> <p>Curriculum time has been allocated so that all year 7 and 8 pupils have a dedicated reading lesson each week. The English department also continued to provide the pupils with a lesson dedicated to reading in the week for all KS3 year groups.</p>
Engaging with National Tutoring Programme and other mentoring intervention programmes.	<p>78% of all pupils on the national tutor programme were pupils who are from the pupil premium band.</p> <p><u>CoachBright in person tuition:</u> We worked with CoachBright to get 46 Year 11 pupils through two rounds of externally provided tuition. Each pupil received 15 hours of tuition in each round. Data showed that 84.8% of pupils achieved at least one grade higher than their starting point.</p> <p><u>Manning's online tuition:</u> Data shows that every pupil made progress on their start point with 70.8% of pupils getting at least one grade more than their start point.</p>
'Motional' Cameron Parker programme.	<p>64 pupils with C/D effort grades were screened. 24 of these pupils went onto the programme and received a total of 3 hours of support (divided into 30 minute sessions) with the coach.</p> <p>According to the final report, all 24 pupils on the programme "<i>fostered a greater sense of well-being, developed their confidence and cemented a direction for their future.</i>"</p> <p>The coach found that 1:1 coaching was most effective as pupils created plans on how they can improve key areas in their lives, not only based on attainment.</p> <p>Mr Parker will be working with us again next year and would like to focus on improving attendance, behaviour and academic outcomes over the next year with targeted pupils.</p>
Intervention at faculty level (Masterclasses)	<p>All year 11 pupils had access to 30 hours of after school masterclass tuition across all subjects and delivered by subject specialist teachers.</p> <p>Year 10 pupils had access to 4 hours of afterschool masterclass tuition to prepare them for their English Literature exam.</p>
Saturday study sessions.	<p>Attendance to Saturday study sessions was 93% on average over the 15 weeks that the programme ran for. 85% of pupils who regularly attended achieved at least one grade higher than their start point.</p> <p>This has been successful and has been refined for 2023/2024 with a more targeted approach. The Maths, Science and English departments will select five more able pupils and five pupils who are not reaching</p>

	their minimum grades and will cover topics to maximise the possibility in greater pupil progress.

2023 External Exam results	<p>Our external data for Summer 23 shows that the Progress 8 score for our Pupil Premium (PP) pupils is 0.45, well above the most recent national PP progress 8 score of -0.55 (2022) and the non-PP national average of 0.15 (2022).</p> <p>The attainment 8 score for our PP pupils is 45.56, again, well above the national attainment 8 score of 37.6 (2022).</p> <p>The progress scores of males and females continues to be positive this year and the gap has reduced so that they are in line with each other at 0.67 and 0.68 respectively.</p>														
Careers Support	<p>An external Careers Advisor came in once per week during the 2022/2023 academic year and did eight interviews per day.</p> <p>By the end of the academic year the Careers Advisor met with a total of 103 pupils.</p> <p>For 2023/2024 they will come in twice a week (Monday & Wednesday), with eight interviews a day. Each interview lasts 30 mins.</p>														

2024 updates

Activity	Actions
Close the attainment gap by moving towards Teaching for Excellence.	<ol style="list-style-type: none"> All departments were given CPM time on their timetable to work on pedagogy and delivery of curriculum content. The school has introduced a new coaching structure, led by the professional practice coaches. Every teacher who requires coaching is placed on an intensive instructional coaching plan. All core subjects were overstaffed to cope with the stresses of cover and staff absence. This also allowed for targeted interventions such as speaking and listening exams in English. It also allowed Maths and Science departments to create additional small classes for interventions.

Achieve national averages for attainment in all subjects.

1. Reading tasks have been added into each curriculum area across KS3 and KS4. This now needs to be developed and monitored over the next year. This will include form time reading.
2. Subject specific key words are shared with pupils and parents at KS3. This can be developed into KS4 schemes of work through 24/25.
3. For 24/25 basic phonics and comprehension tuition will be provided by CoachBright with a focus on improving
4. Year Y7 and Y8 had dedicated reading lessons on their timetables.

To maintain the positive progress score for all pupils.

Hodge Hill College achieved a progress 8 score of +0.19

NTP and tuition

We continued to offer tuition via CoachBright (National Tuition Programme provider) with 61 pupils receiving targeted tuition. The results showed:

In addition, 20 Y7 pupils were provided with 30 hours of tuition to support their basic literacy and numeracy skills. The tutors focussed on enhancing confidence with numbers and literacy skills. CoachBright completed reviews that showed that 96% of pupils improved their confidence with numbers, literacy and metacognition.

NTP funding will cease from September 2024 meaning that external tuition will not be provided and Saturday study session will stop. The model for Saturday study sessions has been adapted to Y11 tuition after school for one hour on Tuesday and Thursday for targeted pupils.

Careers Advisor

333 pupils across Y11 and Y10 met with the careers advisor in 23/24. 24 pupils met the careers advisor twice.

All Y11 pupils will meet with the careers advisor at least once in 24/25.

	<p><u>SEMH needs.</u></p> <p>All pupils were screened for SEMH needs through form time. 84 pupils were identified as needed support across the school. These pupils were given 1 to 1 supports with a specialist in SEMH in school.</p> <p><u>7x and 8x</u></p> <p>We continue to provide distinct curriculum time for 7x and 8x groups to ensure that their needs are met and pupils can access the curriculum. These groups are fluid with pupils moving in and out of the group based on the judgement of the enhanced provision team. There are currently 21 pupils who benefit from this (11 pupils in 7x and 10 pupils in 8x).</p>
<p>To maintain high levels of attendance for all pupils.</p>	<p>The national average attendance for secondary schools was 92.8% in 23/24. The national average for similar secondary schools was 90.9%.</p> <p>The average attendance for each year group was:</p> <p>92.8% for Y7</p> <p>93.9% for Y8</p> <p>92% for Y9</p> <p>92% for Y10</p> <p>91.2% for Y11</p> <p>92.4% was the figure for whole school attendance. Strike days and the effect of two Eid celebrations falling on school days had an impact on overall attendance.</p> <p>We will continue to use the new attendance strategy:</p> <ul style="list-style-type: none"> • We are using SOL attendance monitoring and tracking software to focus in on the weekly change of a pupil's attendance, not just the overall percentage. • This will allow us to address the trickle down from the top and not wait for attendance to fall below a certain point before taking action
